Good quality copies will suffice.

- 1. A copy of your qualification certificate showing the name of the qualification, the name of the awarding institution, the date it was awarded and your name.
- 2. A copy of your diploma supplement describing the nature, level, context, content and status of your studies.
- 3. Details of the course content and syllabus.
- 4. A transcript of each module completed, detailing the credits awarded for each.
- 5. Proof of your change of name if your qualification is in a name other than your current one. It must show both your current name and the name on your qualification certificate.
- 6. Please summarise in an email your career aspirations, if you have experience in the Education sector (roles held, year groups worked with, etc.), and any relevant Continuing Professional Development.

The application deadline to start in October 2022 is <u>19 August 2022</u>. We are unable to accept, and will not consider, applications received after this date.
