#### The Open University Chairs Report 2022 Annual General Meeting

Welcome to the fifty-second annual general meeting of the OU Club.

The main Club has been active with supporting Affiliated Clubs, Nations Manchester and Nottingham with events for staff across The Open University. Many of the activities we have seen have been due to the support of this years' committee and I would like to thank them for their hard work in the past year.

Thanks go to the staff that run the Affiliated Clubs and Social Clubs for their time and hard work which helps the Committee to endeavour that all Affiliated Clubs, the Nations, Manchester and Nottingham can, and will be able to, continue to offer a range of activities to all university staff.

Over the past year it has been good to see that we have begun to get back to some normalcy following covid and that slowly clubs are beginning to run again both on and off campus. We will hear more about these in a report later in the proceedings.

#### What does 2022/23 bring?

At the time of writing both the government and University have lifted all covid restrictions, the only caveat the University continues to add is that anyone with symptoms of or testing positive with Covid should not come on campus for 10 days. This applies to all our clubs and should be included in your risk assessments and communicated to your members. Please remember that activities will only be allowed to restart after an updated Risk Assessment has been completed and approved to make sure all University guidelines have been taken into account.

We continue to work on ideas for all staff for activities that can be enjoyed remotely or in person, please check our intranet site for links and ideas for staff and their families and links to the different clubs to find out what is currently running.

We are, as always, looking to find ways in which we can engage with all staff, including homeworkers, and promote the various Affiliated Clubs and activities across all University sites. We are also working to provide more National discounts for all staff, and to work with the Nations, Manchester & Nottingham to support local discounts where possible.

The OU Club Committee continues to discuss and work on how and what we can do to support the aims of the University. We truly believe that supporting OU staff, with the benefits the OU Club works hard to source, remains important to all University staff, and that the connections and good standing we and the affiliated clubs build within our Local Communities are equally important and beneficial to the reputation of the University. With the continued possibility of social distancing and changes in the university to ways of working, the OU Club is investigating ways we can continue to offer online options for our affiliated clubs to enable as many staff as possible to benefit and take part.

I would also like to remind clubs that part of your constitutions allow that all Affiliated Clubs will submit AGM reports on a yearly basis with financial reports where appropriate.

#### **OU Policy Compliance**

We have continued to work with the University to ensure that Health & Safety measures are met by Affiliated Clubs. We recognise that the additional paperwork does take time to complete and are grateful to those Clubs who continue to complete the yearly Risk Assessment forms in line with University policy. I would like to take this opportunity to remind you that this is a mandatory requirement and all Affiliated Clubs must submit these forms. Failure to complete these may mean your bookings of rooms, or use of equipment, is restricted. Please note that maximum capacities for all rooms used can be found on the Estates Resource Scheduler system and should be adhered to, as should all other University policies when staff are on Campus whether for work or as part of club activities. Please do note that due to Covid-19 and University policy, clubs will not be able to run/restart on campus until they have completed a Risk Assessment and had this signed off by the University.

The Information Rights Office have advised us that they will be undertaking checks to ensure that all clubs are meeting data protection requirements with a view to putting a procedure in place. Please make sure that this included in your constitution and that an up-to-date copy is filed with the OU Club Office.

## Budget

We have submitted our budget request for the next year. As a minimum, we are hoping to retain our current level of funding into the next year, subject to approval by VCE. In the last couple of years, the Committee has had their work cut out trying to distribute the limited funds in a fair and equal manner. I hope that the Nations, Manchester and Nottingham, the Affiliated Clubs and Staff will understand the difficult decisions the Committee faces and will have to continue to face in light of increasingly squeezed budgets, and we appreciate your ongoing support of our Committee. We will continue to advise on, and support, fundraising by Affiliated Clubs.

We will see in a few moments the figures for Club spend in 2021/22 and proposed budget in 2022/23. Financially, funding will be tight for all of us, however, the Committee will be working together with Nations, Manchester & Nottingham and Affiliated Clubs to continue to offer support with activities in the social calendar for all staff.

I would like to thank the many staff in Estates that help behind the scenes, particularly to Noel Fernandes for the support he provides to the OU-Club. I would also like to thank the Events team and the Health & Safety team for their support and hard work in this last year. Thanks also go to Stephen Caferty who has stepped down from his role as Nations, Manchester and Nottingham representative on the Committee after 5years, and to Ed Daynes who is stepping down as Sports Chair after 5years to be a committee member. A special thanks goes to Susan Scimè for all the support she has given me and the rest of the Committee, whilst dealing with the day-day running of the OU Club.

#### The Open University Club Treasurers Report 2022 Annual General Meeting

For 2021/22 we were awarded a budget of £45000.

In September 2021 the bid Committee sat and awarded over £25,000 to the Clubs who submitted bids, a second round of bidding awarded a further £3k. A further bid is still under consideration.

The Covid-19 pandemic and the subsequent restriction of all OU Club activities has left us with a current surplus of around £2500. The OU Club Committee will determine the best way to use these funds.

We appreciate that many clubs will have unspent funds, we would normally ask for these to be repaid but the Committee have decided to allow clubs to carry these funds forward and use them for their activities in 2022/23 This does not preclude you from bidding for more funds should you need them.

We are hoping to review our bidding process and funding guidance for the next financial year. Bid forms will be sent out as soon as possible in July and the return date is still to be agreed. The Bid committee will sit as early as practicable. We are aware that Covid restrictions have impacted OU Clubs, and we are prepared to be as flexible as we can be regarding funding activities. This may include further rounds of bidding later in the financial year if/when things are more certain.

Thanks, as always, go to Sue Scimè and Noel Fernandes for their help and guidance this year and all the Committee members for their support and co-operation over financial decision-making activities.

## **OU Cricket Club**

Cricket returned to OUCC in 2021 following a break due to COVID. We had good support from the OU Club during the season to get the risk assessment approved in record time permitting to play away games due to non-availability of home cricket ground. Thanks to Mahesh (Club Treasurer) for being a wonderful support in seeking the approval.

Overall, it was a difficult season mainly because of Covid. We only managed to play Saturday's league games. One of the major problems was that the home cricket ground was not available. We struggled to arrange alternative grounds. With wonderful initiatives from the club captain, treasurer and secretaries we however managed to have access to Pagers Park in Leighton Buzzard and Emberton cricket grounds. We didn't have any place to do net practice during the season. This impacted the team performance badly and we finished second last on the points table. Yet, the team survived in Division 3. The availability of players was another problem, even though we registered quite a few new members, but still we struggled to stand eleven players on the field in some matches. Due to Covid and other factors, there were a limited number of Umpires available throughout the league, thanks to Mahesh (Club Treasurer) for being available to stand as an Umpire in quite a few matches.

We could anticipate all these problems but still considered play the season. We believe it was the right decision considering if we let all the existing members play elsewhere, it would have been very hard to pull together all these players again. And it may be the end of the OU cricket club and its long history, which would be very sad. Thanks to all the core members of the Club and the new members as well for understanding the problems and their support to me in all ways they could in difficult situations week in, week out.

With situation improving regarding COVID, we look forward to have a better season in 2022 with access to home ground and nets at the Open University.









## **OU Cycling Club**

The Cycling Club has now been running for seven years, although sadly membership has recently declined to its lowest ever level. A lack of willing volunteers to help organise and manage the club has seriously reduced our ability to run events and activities. In addition, the main club activities were always lunchtime training sessions starting at Walton Hall campus, so we have been badly affected by the post-pandemic shift to home working. Milton Keynes is also well-served by several large cycling clubs which compete for members in the local area.

We still provide a selection of annual member benefits, including supply of cycling tools and spares on campus free for members, affiliation to the national governing body, British Cycling, and passes for access to local off-road cycling routes. A handful of activities are still organised for the small number of remaining members. We still keep in touch and participate in active travel initiatives on campus, and a number of members still participate in events and rides locally – give us a wave if you see the distinctive OU Cycling Club jersey out and about. We are keeping the club ticking over on a skeleton committee of Chair and Treasurer, in the hope that we may see a return to higher member numbers and more activities in the future.



## **OU Golf Society**

The OUGS was fortunate to weather the pandemic in reasonably good shape being one of the fortunate groups of people participating in sport and recreation outdoors. The rules of social distancing were of course applied and while play was minimally affected by rules around touching flagsticks and there being no rakes in bunkers, initial fixtures did not allow us to congregate indoors as per usual society outings.

Fortunately were able to rebook most of those fixtures that were suspended during the first lockdown and indeed the society has gone from strength to strength with a health level of regular participation in each day and a full Committee.

Our society does not compete against others and we actively pursue a policy of inclusion rather than selection. As a result we are delighted that in our midst we welcome players of all standard from the very good regular players to the newer recreational players.

Our golf season spans two academic years each season and is played from April to November. There is little joy in winter golf. That means that we have 8 outings, and according to the available light we play competitions over 9, 18, or 36 holes. The formats are intended to ensure that people can socialise, compete and improve irrespective of their standard or physical capacity. And of course the golf handicapping system also ensures that we can level out competitions to spread the opportunities to win prizes.

In addition to the outings, we also run a "Greensomes" competition which is a knockout competition played in pairs. This competition is paid for purely by the members but increases the opportunities for both play and socialising.

We are delighted to have increased the number of women playing and to have a range of age groups now from staff employed at the OU, retired OU staff, family of OU and a small number of associate members. In total we have 45 people on our regular mailing list of which 5 were new this year.

We are extremely grateful for the ongoing support of the OU Club as this enables us to not only ensure that outings are more affordable but it also provides coaching for the members.

### **OU Running Club**

The Running Club has had a quiet year as there just aren't enough staff on site to support a higher level of activity. The monthly lunchtime races have continued virtually, as they did through lockdown, with runners being invited to run the set distance for the month (5k, 5m or 10k) on a course and at a date/time of their own choosing. However, since October we have also organised monthly lunchtime events close to campus to enable runners to complete their runs together using our establish course routes.

Tuesday and Friday lunchtime interval/fartlek sessions have also continued through the year. We are aiming for the annual OURC Tour and Relay Race to return at some point in the future, but these events are very much dependent on more staff returning to campus.



## Squash Club

Another difficult year with initial access to courts being restricted to OU Staff only. OU staff enquiries have escalated significantly during the lockdown and more so now that Walton Hall site has opened up again. It should also be reported that external membership enquiries have escalated to such an extent that we have had to place a hold on these membership numbers.

#### Total Membership 86

The club has continued to pay for England Squash affiliation along with the court booking system. Available funding continues to cover this expenditure with sufficient funding remaining in the bank. No membership fees have been charged for a two-year period. The Squash Committee will be reviewing fees moving forward, now that full access has been granted to all our registered members. We are hoping to revisit new fee structures in June 2022.

Risk Assessment protocols have been implemented along with additional special cleaning routines. Thanks go to all who have enabled us to open up and play squash again. Thanks also go to the players who have signed and acknowledged the rules and regulations associated with the new Risk Assessment document.

Player satisfaction as a result of the opening up of the courts was high however, due to shower refurbishment activities and the time taken to complete this task, our players were not very satisfied. I am pleased to report that the works are now complete, and I have had positive feedback on these up-graded facilities.

We will continue to apply stringent Risk Assessment protocols and players are encouraged to stay safe and be aware that we are all responsible for applying good H&S practices.

## **Table Tennis**

The table tennis club has resumed activities since September 21. Thanks to the financial support from the OU Club, we were able to hire an external venue for weekly practice and hosting our home league matches before club activities were allowed in the campus in April 22. Two teams were competed in the MK league this season. One team finished in 5<sup>th</sup> in Division 1, another also 5<sup>th</sup> in Division 3. Individually, two of our players qualified for the Top 8 tournament and one of them came second in Division 3.

The Club is now practising twice a week in the Hub Theatre on Saturday and Sunday mornings. More and more members are returning. Ten to fifteen people are practising in each session recently.



## Tennis

The club is now back up and running after not being in a position to have activity due to COVID-19. Our current members (n=51) are now able to play on club nights and book the tennis courts to play on. We opened up for new members in May 2022, we have had 11 new members join at that time. We hope to be able to start back up our team matches soon and also offer coaching in 2023.

#### **Ultimate Frisbee**

The Ultimate Frisbee club resumed play on campus from the start of April, after a 2-year gap due to COVID restrictions. Our attendance so far has been an average of 12 players per week, which is roughly the same as it was for the start of our last outdoor season in 2019. It has been a great pleasure to be able to play back on campus again and our sincere thanks to all those in the OU Club and Estates who helped make that happen.

On individual successes, we have two club members taking part in the World Club Championships in Limerick (25 June – 2 July): Joanne Kearns in the Masters Mixed division (30+) and Simon Church in the Great Grand Masters Open division (48+).

### **CD and Vinyl Library**

The CD and Vinyl Library have been closed but are hoping to reopen on Wednesday 7th September with the library open each Wednesday provisionally.

## OU Choir activity 2021/2022

The OU Choir, despite the continued problems for group activities caused by the pandemic, has explored various creative ways to make music in 2021/2022.

There were two strands to our activity during this period. Firstly, the production of our first music video *A different kind of living*, secondly learning a selection of shorter seasonal pieces through the year, which could be managed via a combination of Zoom and face-to-face rehearsals.

The *A different kind of living* project had commenced in December 2020, with music composition by Dr Liz Lane (Associate Lecturer) and words by Judi Moore, rehearsals via zoom and individual audio recordings completed in June 2021. The video element of the project included a video shoot on 3 locations in Milton Keynes (The Light Pyramid in Campbell Park, the grounds surrounding the OU Church and the Concrete Cows in Bancroft Park) with Bill Strang conducting 8 singers (we were limited by permitted numbers for outdoor gatherings at the time) who sang to the audio backing track we had used for the audio recordings. We are grateful to the MK Parks Trust and The Open University for allowing us to use those locations.

The final production and publicity phase of the project took some months to complete, and we launched the video plus the discussion video about the piece in December 2021 on the OU Choir's new YouTube channel <u>A different kind of living - YouTube</u>. We are very proud of our achievement on this online performance project and the main video has had 603 views to date, while the discussion video *Making 'A different kind of living'* has been viewed 247 times. We are planning further promotion of the videos.

The choir committee continued to meet regularly, via online methods (Zoom) only.

The choir resumed some face-to-face rehearsals in October 2021, at hired off campus locations (Old Stratford Community Hall, Aspley Guise Village Hall and St Mary & St Giles Church, Stony Stratford) because at the time we could not yet return to campus. A lot of careful preparation was made to ensure the rehearsals were as safe as possible, including asking members to wear masks until they had reached their seats with chairs spaced 2 metres apart in each large well-ventilated space. We also live-streamed as many of the face-to-face rehearsals as we could, depending on the Wi-Fi strength available, and alternated the occasional face-to-face rehearsals with Zoom only rehearsals.

The choir was finally allowed back on campus on 2 December when we made recordings of 2 carols, in the hub theatre, for the OU Christmas Carol Concert (held online again). The OU Choir finished the term with a short carol singing mini concert on the Mulberry Lawn on 16 December,

an informal event attended by about 40 people. In January and February, with virus cases high, the choir rehearsed via Zoom, returning to campus on 17 March (Berrill Theatre). Since then, on campus rehearsals have been held in the Hub theatre, Berrill Theatre and from May 2022 the OU Church, with live-streaming from Hub and Berrill Theatres possible due to the availability of Wi-Fi. We have live-streamed twice from the Church using a mobile phone as a personal hotspot as the Wi-Fi being installed is not yet ready for us to use. From September we plan to continue live-streaming rehearsals for those who are not well enough to join face-to-face but want to participate.

The choir is currently in the final rehearsals for a planned concert on in the Hub Theatre on campus scheduled for Friday 8 July featuring the seasonal music we have been rehearsing since June 2021.

#### **Core Fitness**



OU Core Fitness Club has not been running for the last two years, due to the pandemic, although many members have been participating in the online classes that are arranged by our Tutor, open to the general public to book. We are extremely grateful to Hannah for continuing to offer these.

We have not requested to resume campus-based classes yet due to lack of demand at the moment.

Our 5<sup>th</sup> AGM will be in November 2022. We will inform the OU Club once we have agreed the date.

## Craft Club

The Craft group has not met on campus during the last twelve months.

We have however had a few lunches out at a local pub, to discuss our individual projects.

There is no planned return to meetings on campus for the foreseeable future, as most of us are still working from home.

We may use Teams to meet in the future.

#### **OU Orchestra and Chamber Music Club**

#### Looking back at the past 12 months

After a break of 20 months, we resumed on-campus rehearsals on 5<sup>th</sup> November 2021. Almost all our members chose to return, and rehearsals have been well attended. Initially we maintained very tight covid restrictions in line with our risk assessment and OU policies, and we continue to keep our members safe by maintaining socially distanced rehearsals and with good ventilation in the Hub Theatre.

We held our AGM on the 12<sup>th</sup> November via MS Teams. This was very well attended and gave us the opportunity to canvas opinions about future rehearsals and concerts.

In December 2021 we recorded several pieces for inclusion in the streamed OU Carol Concert.

We resumed collecting membership subs from our players from January 2022 after an 18-month break and have received 33 subs to date this year.

Exactly 17 years since the orchestra's inaugural concert, we gave our first in-person concert since the pandemic on Friday 20<sup>th</sup> May. We performed Elgar's Bavarian Dances and Tchaikovsky's 2nd Symphony, conducted by Catherine Rose. The concert was streamed online to the wider OU community, watched live by 38 people, and was attended in person by an audience of 101 staff, friends and family with free tickets booked via EventBrite. The orchestra would like to thank the AV department for streaming the concert via Stadium, and Estates for supporting our rehearsals and our recent concert.

#### Changes made for a new working landscape

To meet the challenges presented by hybrid working for many of our members, we have trialled a new rehearsal schedule. Since November 2022 we have held two Friday lunchtime rehearsals per month, with a longer monthly Sunday afternoon rehearsal all in the Hub Theatre. This has been well received by our member but needs to be regularly reviewed, and a return to our weekly Friday lunchtime rehearsals has not been ruled out at this stage.

#### Into the future

Our committee has recently requested additional Club funding to support the purchase of a third timpani and orchestral bass drum and are delighted to have been successful in our application.

We are very keen to resume our extremely successful schools outreach events. We recognise the challenges that welcoming school children onto campus may create and are considering the best way to proceed with these events. We will, as always, work closely with the Club, Estates and Health & Safety in this matter.

We will now recommence our usual twice-yearly public concert programme, and commence rehearsals for our next public concert, scheduled for October 2022, from June. The committee recognise that, as more staff and events return to campus, there may be increasing use of the Hub Theatre in the coming months. As this remains our only viable oncampus rehearsal and concert space we will be working closely with the Events Office to secure advance bookings and protect key rehearsals and concerts where we can.

We would like to encourage recruitment of new members from the increase in OU staff and will seek to publicise the orchestra, with Club support, in the coming year.

We aspire to once again provide free chamber music and small ensemble bi-monthly lunchtime concerts which are open to OU staff and the wider community.
